## **New business**

trusted servants can request reimbursement for the travel to area. Potential guideline changes to be had if approved to meet 6 times a year the living document should reflect that... A written motion to amend the guidelines to be made using the secretary minutes. The chair suggested we start using written motions to bring back to region to be voted on.

Vote to dono 500 smackeronis a year to the WSZF instead of the 300 we already do. To go above and beyond the ask from zonal of 101\$ increase. Gsr's make decisions at area level. RCM's represent the groups voices, to serve the best interests of their members. This would be a change in the guidelines. Treasurer to write a check for the 200 difference for 2026. Motion to 500 a year to wszf approved by cbdm.
